STCU 23rd BOARD RECORD OF DECISIONS – NOVEMBER 16, '06



The STCU Governing Board, at its 23rd meeting, made the following decisions:

- ➤ Approved twenty-eight (28) regular projects (including continuations) for a total of \$687,869 + €2,731,390.
- ➤ Approved ten (10) Targeted R&D Initiative projects for a total of USD \$354,076 and €111,995.
- ➤ 2007 Administrative Operating Budget (AOB) approved as presented (Total \$1,733,079): sharing ratios for the 2007 AOB and Shared Supplemental Budgets (SB) will be USA 62.28%, EU 30.39%, and Canada 7.33%.
- Approved Supplemental Budget (SB) revisions reflecting an increase of \$158,000 to Activity 04.01, an increase of \$48,400 to Activity 05.01, an increase of \$40,00 to Activity 06.01, an increase of \$100,000 to Activity 09.01, and an increase of \$59,000 to Activity 12.01, using the sharing ratios identified, as well as \$1,000,000 assigned to Activities by the USA, €726,084 assigned to Activities by the EU, \$537,359 assigned to Activities by CA and \$142,000 assigned to Activities by Partners.
- Approved the utilization of unspent E.U. solely-funded Supplemental budget lines at the end of STCU fiscal year 2006 for E.U. projects or for return to the European Commission as directed by the European Commission. Shared Supplemental Budget lines, as well as U.S. and Canadian solely-funded Supplemental Budget lines will remain in their respective Supplemental Budget lines to be used in 2007. The Funding Parties agreed to further review the procedure of funding all Supplemental Budget lines in 2007, with the goal of moving to a system where all Supplemental Budget lines are "zeroed out" at the end of the year, beginning with fiscal year 2007, and are replenished with the new gross request in the subsequent year, beginning with fiscal year 2008.
- Approved greater than ten (10) percent overspend of 2006 Administrative Operating Budget (AOB) bank fees-offshore, legal services, and telecommunications services line items.
- ➤ Confirmed extension of current Senior Deputy Executive Director (UA) Borys Atamanenko until the 24th STCU Governing Board in spring 2007.
- Approved the concept of "joint ISTC-STCU Partner Projects" and instructed the STCU Secretariat to work with the ISTC Secretariat on appropriate amendments to the current ISTC-STCU Administrative Arrangement on Joint Projects.
- Approved a change in Partner Project Procedures, changing the time period allowed for Party approval of a Partner Project Proposal from the current 45 days to 40 days.
