- 1 Science and Technology Centre in Ukraine (STCU) is an intergovernmental non-profit organization established to support research and development activities for peaceful applications by scientists and engineers formerly involved with the development of weapons of mass destruction. STCU's activity is governed by the intergovernmental Agreement on the establishment of the Science and Technology Centre in Ukraine that was initially signed by Canada, Sweden, Ukraine, and the United States of America. Subsequently, the European Union replaced Sweden, and Azerbaijan, Georgia, Uzbekistan and Moldova joined the countries who had signed the Agreement. In addition to funding research projects, STCU is active in other fields including the searching of scientific partners, conducting the on-site presentations, scientific workshops, implementation of partnership projects, providing grants for overseas travel and supporting the patenting.
- 2 STCU (hereinafter referred to as the Employer) intends, for purposes of the Project no. 9708, which is being implemented jointly with State Specialized Enterprise *Ecocentre*, to procure one (1) whole-body in-vivo counter and one (1) liquid nitrogen filling system described in these tender documents and hereby invites you as a potential supplier to submit your tender.
- 3 This tender is open to all firms and individuals. However, firms and individuals of a country may be ineligible if by an act of compliance with a decision of the United Nations Security Council taken under Chapter VII of the Charter of the United Nations, a decision of the government of Ukraine and of the government of the countries wherein the Employer is performing this project prohibits any import of goods from that country or any payments to any country, person, or entity in that country.
- 4 To qualify to tender, firms and individuals shall be able to demonstrate:
 - (a) evidence of experience in manufacturing and/or supplying the goods to be procured under this tender in the past three (3) years;
 - (b) the availability of personnel, equipment, technology, and tools necessary to perform the contract;
 - (c) the availability of current assets sufficient to fund the contract.
